



## Children's Product Certificate San Joaquin Fine Woodworkers Association

Section 14(g) of the Consumer Product Safety Improvement Act (CPSIA), 15 U.S.C. § 2063(g) requires manufacturers, importers, and private labels (foreign and domestic) to certify that all products manufactured on or after November 12, 2008, are compliant with all applicable standards, rules, and bans enforced by the CPSC. This Children's Product Certificate (CPC) certifies compliance. This CPC is not required to be signed or filed with any government regulator, but must be available for inspection for five years. The CPC must be provided in English and is based on the testing of each product type. The results summarized here are based on the toy testing program developed by the Association. The Association is registered with the CPSC as a Small Batch manufacturer. The testing program follows the procedures and guidelines of the CPSC's 2010 Laboratory Test manual for toy testing and ASTM F963-11
