



## Children's Product Certificate San Joaquin Fine Woodworkers Association

Section 14(g) of the Consumer Product Safety Act, 15 U.S.C. § 2063(g) requires manufacturers, importers, and private labels (foreign and domestic) to certify that all products manufactured on or after November 12, 2008, are compliant with all applicable standards, rules, and bans enforced by the CPSC.

Compliance shall be evidence by a Children's Product Certificate (CPC). This CPC is not required to be signed or filed with any government regulator, but must be available for inspection and kept for five years. The CPC must be provided in English and based on a test of each product or a reasonable testing program.

The testing and resulting summarized in this document is based on the Association registering with the CPSC as a Small Batch manufacturer and implementing the toy testing program developed by the Association. This testing program follows the testing procedures and guidelines of the CPSC's 2010 Laboratory Test manual for Toy testing and ASTM F963-11
